# 2020 Recruitment and New Membership:

Dear Compatriots and Friends,

2020 has been a disturbing, complicated and sad year in so many ways. As we leave this year, participate in the holidays and look forward to 2021 I think it's time for us to consider renewing some things.

First, I think we should renew the ties that bind us to friends, family and loved ones, as well as renewing our support to our preferred charities that help those who suffer, whom we have never met and probably never will meet.

Second, comes the matter of renewing Faith. I know these are contentious times. The scene at the Constitutional Convention in Philadelphia was very contentious causing Benjamin Franklin to put forward this proposal on June 28, 1787 as reported in James Madison's Notebook.

"We shall be divided by our little partial local interests; our projects will be confounded; and we ourselves shall become a reproach and by-word down to future ages ... I therefore beg leave to move - that henceforth prayers imploring the assistance of Heaven, and its blessings on our deliberations, be held in this Assembly every morning before we proceed to business, and that one or more of the clergy of this city be requested to officiate in that service." You guessed it - contentious debate followed. The Assembly adjourned with out voting on the motion. But a seed had been planted.

And then third - renew your determination. The SAR Magazine reports that in the darkest days at Valley Forge George Washington wrote a letter of resignation. He heard conversation outside of his tent. He went outside and asked the men if they'd had enough. One lieutenant said "Having come this far, we can but go the rest of the distance". Washington burned his letter of resignation.

Stay safe. Stay well. I look forward to seeing all of you by Zoom two days after Christmas Sunday, December 27th at 1:30 pm.
