PRESIDENT'S MESSAGE

Compatriots and Friends,

Let me start with a welcome to our three newest members: Ken and Konnor Williams, and Paul Moore. We began 2024 with 75 members, and we are now at 78 with one reinstatement pending SAR approval. The new member profiles for Ken and Konnor appear on the last page of this newsletter. The profile for Paul will be published in next month's newsletter.

In 2023 we experienced a significant increase in membership (27%), and we also saw an increase in member attendance at our lunch meetings, now averaging 16 or more. For 2024, I hope we can channel some of this increased energy and enthusiasm into more member participation in the planning and implementation of the various functions and programs we carry out throughout the year. I will give three examples.

First. Recently, Mark Snider completed and submitted the annual U.S. Stark Awards Program Report where the Chapter documented 6,109 points earned for its 2023 support and assistance to veterans and veterans support organizations. I also sent out our 2023 Americanism Report which incorporates the veterans support activities and includes all other SAR recognized activities carried out by the Chapter. In this report, we earned 75% of the points qualifying under the Americanism category for SAR community educational outreach, and 100% of the points under the PG Streamer category qualifying for SAR administrative support. In my nearly five years with SAR - the Chapter has never achieved enough points to be recognized under either category for national consideration of the PG Cup award. Congratulations to all who actively contributed to make this happen. As you look through the various tabs used in both reports, you will see program activities that you can be part of in carrying out 2024 activities.

Second. Under our Bylaws, the president may create (and dissolve) ad hoc committees. Some may have a limited purpose after which it is dissolved. Others may have a broader and longer range purpose which may be continued from one year to another. AMERICA 250 THE FRANCO-AMERICAN ALLIANCE - FEBRUARY 6, 1778 By Kevin Shurte

School children everywhere learn of Lord Cornwallis' surrender at the Battle of Yorktown – a surrender that fundamentally ended the fighting of the American Revolution. Yet this secession of hostilities did not come about solely at the hands of the Continentals, under the command of General George Washington, but resulted from years of cooperation and collaboration between French and American forces against a common foe.

In the aftermath of defeat to the British in the French and Indian War, the French government desperately sought means by which to humiliate and retaliate against its longtime enemy. Early on, the French began infiltrating Colonial America, attempting to gauge the level of societal discontentment with British rule. After open hostilities began between the colonists and British regulars at the Battles of Lexington and Concord, the French immediately commenced to surreptitiously funnel financial aid and military supplies to the American rebels through the Spanish holding company, Roderigue Hortalez and Company. This support proved essential in sustaining the Continentals early in the fight.

Numerous French volunteers also assisted during the opening years of the conflict. Some fought for fame and fortune. Others fought to secure the promise of a new form of government based on liberty and equality. The Marquis de Lafayette is the best-known among those Franco volunteers. A French nobleman, Lafayette arrived in America in 1777 and was appointed the rank of major general in the Continental Army despite his lack of combat experience. Serving with distinction at the Battle of Brandywine on September 11, 1777, Lafayette soon commanded his own division and came to develop a strong and lasting friendship with General George Washington.

While the covert aid France provided was valuable, its overt aid would prove invaluable to the cause of American independence. By 1776, the Continental Congress had established diplomatic relations with France, mostly notably, through the efforts of Benjamin Franklin. As Ambassador to France, Franklin and others sought to gain official recognition from and alliance with Frances' ruling house of Bourbon. However, the monarchy required assurance that America was worthy of its support. This assurance came on October 17, 1777, following Gates' victory over Burgoyne at Saratoga. After years of supplying the Continental Army through backchannels, on February 6, 1778, France and America signed two treaties in which France officially recognized America as an independent nation, established commerce, and entered a military alliance against Great Britain.

The Franco-American Alliance of 1778 altered the course of America's war for independence. In 1778 and 1779, the French Fleet began pressing the British at Newport, Rhode Island and Savannah, Georgia, respectively. In 1780, approximately 6,000 French troops arrived in Rhode Island under the command of Rochambeau. These French forces combined with Washington's Continentals and completed a 14-week march from Newport, Rhode Island to Yorktown, Virginia where they and the French Fleet snared Cornwallis' army and secured America's liberty.

Most historians agree about the impact the Franco-American Alliance had on the outcome of the American Revolution. France's entry into the conflict not only provided essential aid to the Continental war effort in North America but also sparked the Anglo-French War of 1778 which allied France, Spain, and the Netherlands against a common adversary – Great Britain. The Bourbon War, as it is also called, forced Britain to reconsider its position in the American colonies and reallocate its resources to protect its colonial holdings in the West Indies, India, and the Mediterranean. By forcing Britian to divert finances and manpower away from its war effort in the 13 American colonies, the Franco-American Alliance of 1778 ensured a French and American victory over the British in North America.

SAR MEMBER PROFILE Ken Williams By Chuck Adams

Q. Ok Ken, can you tell us a little bit about yourself?

A. I was born in Huntington, West Virginia in 1959. Raised in Fort Lauderdale, I

have resided in Broward County for the past fifty-six years. Currently, I live in The Town of Davie where I have resided for the past twenty-seven years. I graduated from Barry University with a bachelor's degree in public administration.

Q. What is or was your occupation?

A. I was a firefighter/paramedic. Thirty of my thirty-six years in Fire / Emergency Medical Services were served in Miami-Dade County Fire Rescue (MDFR). I retired in 2018 with the rank of Battalion Chief. In addition, I was a member of FEMA's Urban Search and Rescue Task Force with Florida Task Force 1 (FL-TF1). We responded to natural disasters such as hurricane response and building collapse. In 2011, our team deployed to provide search and rescue efforts in the aftermath of the Haiti earthquake. Also, I served as a rescue diver for thirty years with MDFR.

- Q. Can you tell us about some of your recreational interests?
- A. I enjoy nature photography. I also enjoy inshore fishing in Everglades National Park and the Florida Bay. In addition, I like camping and hiking.
- Q. How about your family?
- A. I am currently in a relationship with a wonderful woman. I have two children, one of which is Konnor Williams who is in Paramedic school to become a firefighter / paramedic. He also was recently approved as a member of SAR. My daughter, Emily, just graduated from Broward College and is looking forward to continuing her education.
- Q. Who is your Patriot ancestor?
- A. My patriot is William Lawson Jr. As a private, he served in 1779 for three months in a North Carolina militia regiment. Subsequently, in 1781, he served another three months in another North Carolina militia regiment. He was granted a pension in 1832. He died in Scott County, Virginia on 30 Jan 1852, age about 89.
- Q. Do you plan to contribute to and help with Chapter develop, retain and attract members, or recognize others consistent with SAR programs?
- A. Yes. Currently, I am serving as Chapter meeting photographer, and will help in other ways as I can.
