#### GENERAL MEMBERSHIP MEETING SUMMARY NOVEMBER 11, 2023

At our November 11, 2023, meeting we had 14 members and 3 guests for a total attendance of 17. Members (14): Chuck Adams ca, President & Registrar/Genealogist; Steve DePaul ca, Vice President & Sergeant-at-Arms; Mark Snider ca, Secretary; Kevin Shurte ca, Historian; Tim McLane ca, Chaplain; Jim Clark; Paul DeBold; Herb Gardener, Martin Hollick, James Lohmeyer; Barry Moss; Lincoln Pero, and Tom Shepherd. Prospective Members / Guests (3): Kenneth Williams, Prospect; Paul Moore, Prospect; and Claudia Perry, Wreaths Across America Rep. The superscript ca records compatriots attending in colonial attire and participating in the Color Guard.

Color Guardsmen Steve DePaul, Tim McLane, Kevin Shurte, & Mark Snider presented the colors with Chuck Adams leading the assembly in the SAR Pledge and the Pledge of Allegiance.

Chuck Adams recognized the presence of our newest applicant, Paul Moore. He said that year to date, our membership has increased from 59 to net 75, and that there will be three applications pending SAR approval at year end. all but six have renewed their membership for 2024.

Steve DePaul provided an update on the Liberty Tree Dedication Project, and provided the status of his discussions with Dania Beach, Pompano Beach and Tamarac.

Mark Snider stated that the Executive Committee approved via e-mail the amended budget as of October 31, 2023.

Mark Snider stated that 4,035 points have been accumulated to date by the Chapter for the 2023 Stark Awards Program. He outlined the SAR Partners in Patriotism Award Certificate which is awarded which is awarded To Chapters reporting "Activities Supporting Veterans in Cooperation with other Organizations" as part of the annual Stark Awards Program Report.

Chuck Adams gave the Status of Fund Report as of October 31, 2023. He stated that the November 2023 Newsletter includes the Member Profile of Eric P. Knott who's application was recently approved by SAR. On 2023 youth programs, Chuck Adams reported that he and Kevin Shurte attended the November 5, 2023, Swamp Fox Society C.A.R. meeting which was held at Gumbo Limbo Nature Center in Boca Raton.

Kevin Shurte presented the 250 Anniversary Recognition Program Report. This month he summarized his report on *the Patriots Capture of Montreal*, which is also published in the November 2023 Newsletter.

An update was provided by Claudia Perry on the Wreaths Across America ceremony being held on December 16, 2023, at the Forest Lawn North Memorial Gardens. Chuck Adams presented her with the Chapter check for \$408, noting that 50% of that amount was contributed by the H.S. White Corporation of Pompano Beach.

Mark Snider stated that the Chapter, as a member of the Vietnam War Commemorative Partner Program, periodically recognizes Vietnam War era veterans. In the Chapter, he recognized Jim Clark and Paul DeBold for their military service during the period of 1954 – 1975. Chuck Adams stated that in commemoration of Veteran's Day that he had SAR Veteran's Committee Challenge Coins for all of our Chapter veterans. He and Mark distributed coins to the veteran members present: Jim Clark, Paul DeBold, Jim Lohmeyer, and Tim McLane.

Chuck Adams presented medals, certificates and awards to the following Chapter Compatriots:

- 1. Samuel Nicholas Camp # 23 Color Guard. SAR Color Guard Challenge Coins and Chapter Certificates were presented to the founding members of the Fort Lauderdale SAR Color Guard: Chuck Adams, Steve DePaul, Tom Carpenter Jr (not present), Tim McLane, Kevin Shurte and Mark Snider.
- 2. Membership Service. Tom Shepherd was presented with his 5-Year Membership Award.
- 3. 250 Anniversary Recognition Awards. Tom Shepherd was presented with the Bronze Certificate; Chuck Adams, Steve DePaul, and Mark Snider were presented the Silver Certificate & Medal; and Kevin Shurte was presented the Gold Certificate & Medal.

## AMERICA 250 THE GOLDEN HILL RIOT – JANUARY 19, 1770 By Kevin Shurte

Just as the battles of Lexington and Concord marked the opening shots of the American Revolution, so too did the Golden Hill Riot mark its first bloodshed. The Golden Hill Riot, commonly referred to as the Battle of Golden Hill, was one of the earliest clashes arising between American patriots and British regulars.

Following the conclusion of the French and Indian War in 1763, the British government opted to keep a standing army in North America to maintain control over their newly conquered land holdings in Florida and Canada, as well as to suppress possible Indian uprisings. As part of this peacetime force, 1,500 British soldiers arrived in New York City in 1766. In accordance with the parliamentary Quartering Act of 1765, colonial legislatures were responsible for providing barracks or public housing accommodations for all British troops. However, the New York Assembly refused to levy taxes to comply with this dictate, thus many of the newly arrived soldiers had no quarters in the existing city barracks and had to billet aboard their ships.

Adding insult to injury, the New York Sons of Liberty, formed in 1765 by John Lamb, Alexander McDougall, and Isaac Sears in response to Parliament's passage of the Stamp Act, had erected a series of 4 liberty poles to date on the Common outside Montagne's Tavern near the corners of Murrays Street and Broad Way, one block south of the British barracks. British soldiers had felled the first three liberty poles constructed of wood, so the patriots cast the lower portion of the fourth pole in iron. From 1767 to 1770, British soldiers made several unsuccessful attempts to destroy this hardened target by means of cutting and digging. Finally, on the night of January 13, 1770, redcoats attempted to explode the liberty pole with gunpowder. However, patrons of Montagne's Tavern discovered the saboteurs and began heckling them. Reacting to this verbal harassment, the soldiers drew their swords, fixed their bayonets, and stormed and vandalized the premises. This ransacking sparked civil unrest in NYC over the next week.

On January 15, an anonymous broadside published under the pseudonym "Brutus" appeared on the streets. This appeal asserted that British soldiers were not present to protect but to enslave the citizen population. It directed those who sought to learn more and further the Cause to meet at the liberty pole at noon on January 17. However, the night before the meeting was to take place, British soldiers crept out in darkness and succeeded in downing the symbol of resistance, exploding its iron base, chopping its wooden pole, and spitefully littering its debris at the doorway of Montagne's Tavern.

The next day 2,000-3,000 patriots answered the broadside's call and gathered at the Common where they discussed their outrage over the billeting of soldiers and resolved to treat "any soldier who behaved in an insulting manner" as an enemy of the peace (Bacelar). The British 16<sup>th</sup> Regiment of Foot responded with their own missive titled "God and a Soldier" which claimed responsibility for the destruction of the liberty pole, labeled the Sons of Liberty as the true enemies of peace, and ridiculed them for clinging to a piece of wood for their freedom.

Hostilities finally boiled over in Manhattan on January 19, 1770. The conflict started with patriots Isaac Sears and Walter Quackenbush attempting to prevent soldiers posting their "God and a Soldier" leaflets. The incident began to escalate as additional soldiers arrived with fixed bayonets. Attempting to pacify the situation, NYC mayor Whitehead Hicks ordered the soldiers to return to their barracks. Armed with knives, clubs, and a halberd, the crowd followed until encountering British reinforcements on Golden Hill. Here the regulars drew their weapons and taunted the crowd, "Where are your Sons of Liberty now?" (New York Historical Society). Consequently, a brawl soon erupted, and a riot spread throughout the neighborhood.

While no deaths occurred, combatants on both sides suffered beatings and stabbings in addition to injuries inflicted on unarmed, uninvolved citizens. Golden Hill Riot marks the first incident of open aggression between American colonists and British soldiers and the first instance of blood spilt relative to the coming war. Just six weeks later, British troops would fire upon another group of colonists in another city killing five in what has come to be known as the Boston Massacre.

#### SWAMP FOX SOCIETY C.A.R. Tomorrow's Rainbow - December 3, 2023

The end of year holiday meeting of the Swamp Fox Society C.A.R. was held on December 3, 2023, at Tomorrow's Rainbow. This 501 c (3) non-profit organization is located in Coconut Creek and has been in operation there since 2005. It offers individual therapy to children, teens, and individuals who have experienced grief, loss, or trauma. It specializes in the use of equine assisted therapy offered by licensed practitioners using Tomorrow's Rainbow herd of twelve or more ponies, two horses, two donkeys and several sheep and goats and other small barnyard animals.

Services are offered for free and Tomorrow's Rainbow counsels approximately 500 to 600 qualifying individuals per year. They are supported by grants and foundations, corporate and individual donations and proceeds from fundraising events. Q. Ok Blair, can you tell us a little bit about yourself?

Q. How about your family?

A. I have been married to the love of my life and best friend, Valerie, now for 41 years. After getting married in 1982, we relocated to South Florida and have become "native" Floridians (transplants) ever since. Our son Ryan is 35 years old and works for Publix. Our daughter Shannon sadly passed away at the age of 19 from diabetes complications. We support our local horse and ferret rescues as well as the Humane Society and Society for the Prevention of Cruelty to Animals (SPCA). Nationally, we support the Juvenile Diabetes Research Foundation (JDRF) and St. Jude's Children's Hospital.

Q. Who is your Patriot ancestor?

A. My patriot ancestor was Captain David Dickson (Dixon) of South Carolina. He commanded a company in 1776 under Brigadier General Williamson. In 1777 he brought a company of Minute Men to Georgia and was stationed on the Frontier. In 1778 his company served in the Artillery during the third failed invasion of East Florida attempting to capture St. Augustine.
