Speaker of the Day - Chase Adams

The guest speaker is an attorney who has an extensive background in business, law and finance and has served the community and country on numerous committees. On this occasion, however, he spoke about a subject dear to his heart, the Constitution and one of its current challenges -- excessive federal taxation

He pointed out that the key to the success of our country has been its timeless constitution which provides the basis for a unified, simple plan of government operation. Its original goal was to establish government regulation for those things logically best handled by a central body, leaving the states to regulate everything else. Mr. Adams' main theme was that governmental taxation, as established in 1909 by the 16th Amendment (purportedly to finance WW I), has been distorted to create a centralizing power in Washington and limited authority by the states. Repeal of this amendment is being supported by a large number of governors and in congress by bills referred to as "fair tax" and "liberty" amendments. It was explained that these bills provide 10 years to establish alternative taxation and management procedures, but the key message was that the time to act is now. – Follow-up information will be sent to those interested in knowing more and, hopefully, who will add their support.
