Fort Lauderdale Chapter Sons of the American Revolution Minutes of Meeting on May 16, 2010 Held at Colony West Country Club in Tamarac, Florida

The meeting was opened at 12:00 PM by President Charles Crowell with 27 members and guests present. The invocation was offered by Fr. Cass Daly followed by the Pledge of Allegiance to the Flag and the SAR Pledge, each led by the President.

The President asked each of the members and guests present to introduce themselves. Following the introductions the President started a conversation on various aspects of the SAR in which he was joined by several other members.

The President then asked the officers of the Chapter to report with the following results:

Vice President: Vice President Flannery had nothing to report on Chapter business. However, since the meeting was being held on Armed Forces Day he did the appropriate research, found the original wording of the Proclamation by President Truman establishing the day, and shared it with the chapter.

Secretary: The Secretary noted that the minutes had been distributed with the newsletter and asked that they be approved. This was moved by Ted Duay, seconded by Joe Motes, and approved by a voice vote.

Treasurer/Newsletter: Treasurer and Publisher of the Chapter Newsletter Joe Motes presented the treasurers report that indicated a current balance in the operating account of \$3,592.50 and \$14,573.12 in the Trust Fund. He also asked for help in covering JROTC meetings for presentation of awards and Ted Duay volunteered to cover the two meetings for which there was a conflict in meeting times. Joe also asked for motion to approve a \$200.00 gift to the local CAR chapter, and this was moved by Paul Blackinton, seconded by Ted Duay, and approved by a voice vote. Jim Lohmeyer moved that the Chapter reimburse Joe Motes \$250 to defer a part of his travel costs associated with his representation of the Chapter at JROTC events. The second was from Ted Duay and the motion was approved by a voice vote.

Genealogist/Registrar: Ted Duay did not present a report.

Following a break for lunch, Paul and Dan Blackinton read the citation and the Chapter presented the SAR Law Enforcement Commendation Medal to Corporal Roger Good of the Broward Sheriff's Office. The purpose of the program is to recognize an outstanding member of the law enforcement community who has served with distinction and devotion and the Chapter solicited recommendations from the Sheriff's Office.

The President presented an award from the Chapter to Mr. William Ballenger from St. Andrews School in Boca Raton recognizing his merit as an instructor at that institution. Following the presentation Mr. Ballenger delivered a talk centered around the question of whether certain notable figures in history are notable because of the events occurring at that time in which they participated or, instead, they drove the events. As an example he recounted the actions of George Washington in suppressing a mutinous meeting of some officers of the Continental Army in 1783.

The meeting was concluded with a benediction delivered by Fr. Cass Daly and the SAR Recessional led by the President.

CHAPTER TRUST FUND

The Fort Lauderdale Chapter SAR Trust Fund was established in 1991 and has grown to its current balance of approx \$14,573. The stated purpose of this fund is to assist in the operation of the Chapter, including its projects and expenses. Only the earnings of the Trust may be utilized, never the principal. Including extra dollars in your check for the trust fund will be very helpful and appreciated.

Florida State Park Vet Passes: State Park Fees for Veterans S.B.2256 introduced by Sen. Andy Gardiner (R-9) and H.B.1145 introduced by Rep. Leonard Bembry (D-70) has been passed and sent to the and or gratus Entrance Passes to eligible members of the military community who present proof of eligibility:

- 25% discounted Annual Entrance Passes for active duty and honorably discharged veterans of the United States Armed Forces, National Guard or reserve units of the U.S. Armed Forces or National Guard.
- No cost Life Entrance Passes for veterans with service related disabilities and surviving spouses of members of the US military who have fallen in combat.

The discounted Florida State Parks Annual Entrance Pass is only available for purchase at any Florida State Park staffed ranger station. The no cost annual Life pass can only be obtained at a staffed ranger station. A list of staffed ranger stations can be found at

Satisfactory written documentation to prove eligibility includes current military identification card showing the bearer as active duty, reserve or retired member of a branch of the Department of Defense, or Personal identification (i.e.: driver license) and:

- Most recent DD Form 214, Certificate of Release or Discharge from Active Duty, showing the named individual's Character of Service as Honorable, or
- Other current official documentation from the Department of Defense, or one of its branches, naming the bearer as active duty, reserve, veteran or retired military, or
- Current official documentation from the Department of Defense, or one of its branches, naming the bearer as having sustained a service-related disability, or
- The final DD Form 214, Certificate of Release or Discharge from Active Duty, showing the date of death as the same date as the date of separation, and Marriage certificate or license, or death certificate showing the bearer as the spouse of the military member who has fallen in combat.

National Park Passports: In addition to the senior pass available to U.S. citizens or permanent residents who are at least 62 years old for a one-time processing fee of \$10, the following can be obtained:

- Access Pass: A Free Pass for People with Disabilities. It is a special permit for people of any age who are medically determined to be blind or have other permanent disabilities. It offers the same benefits as the Senior Pass, but it is completely without charge. No processing fee is charged for the Access Pass. Like the Senior Pass to national parks, the Access Pass cannot be purchased by mail or online. It must be obtained in person at a federal area where an entrance fee is charged. To qualify for the free Access Pass to national parks, you will need to provide one of the following: a statement from a licensed physician, a document issued by a Federal agency such as the Veteran's Administration, proof of Social Security Disability Income or Supplemental Security Income, or a document issued by a state agency such as a vocational rehabilitation agency.
- A One-Year National Parks Pass for People Under Age 62. If you are under age 62 and do not qualify for a Senior Pass to national parks, you can still save money by purchasing an Annual Pass, which costs \$80 and is good for one year from the date of purchase. At national parks, monuments and recreation areas that charge a per-vehicle fee, the Annual Pass to national parks admits you and your passengers without charge. Where a per-person fee is charged, the pass admits you plus three other adults (children under 16 are not subject to charges). There are three ways to purchase an Annual Pass to U.S. National Parks. In person at a national park that charges an

- entrance fee, online from the National Park Service Annual Pass site http://store.usgs.gov/pass/index.html, or by calling 1-888-ASK-USGS, Ext. 1
- Volunteer Pass. If you enjoy the national parks and want to help out by becoming a volunteer you can get an complementary annual pass for your efforts. You'll receive the same discounts and national park benefits as the Annual Pass described above, but the Volunteer Pass is available to volunteers who provide 500 hours of cumulative service. 2010 NSSAR ANNUAL CONGRESS REPORT

Dear Compatriots:

In July, I attended the SAR Annual Congress in Cleveland and had a wonderful time. I always enjoy meeting new compatriots from around the country as well as catching up with old friends. The Ohio Society was a most gracious host to all.

In Cleveland, despite running a good campaign, Paul Hays of the DC Society was unsuccessful in defeating the incumbent for Genealogist General. Compatriot Hays will be running again for Genealogist General in 2011 and I hope that the Florida Society will continue to support and endorse him.

Another item of interest in Cleveland was discussion of the Tennessee Amendment that was supported by the Florida Society and many other states. After lively discussion, Rick Hollis, President of the Tennessee Society, made a motion that passed to table the amendment indefinitely – in other words, through the end of Congress. The rationale for this decision was that many compatriots supported the changes advocated by the Tennessee Amendment but thought that those changes should be considered and made by the SAR Genealogy Committee at the Fall Leadership meeting in September.

David Sympson, the newly elected President General, dramatically altered the membership of the SAR Genealogy Committee in a number of ways:

- (1) Reduced the membership of the committee from 58 members to 21 members;
- (2) Replaced both the Chairman and Vice Chairman of the committee. The new Chairman is Stan Evans of Tennessee (formerly Florida SAR President) and the new Vice Chairman is J. Michael Jones from Arizona;
- (3) Changed the composition so that no state has more than one member on the committee;
- (4) Removed the Genealogist General as an Ex-Officio member of the committee;
- Removed any past PG or SAR staff member from the committee.

I commend PG Sympson on his changes to the committee and I am hopeful that the new committee will promulgate genealogical policies that will enhance membership growth and streamline the application process.

PG Sympson has also shown his commitment to streamlining the SAR application process and reducing approval time by preparing and sending a memo to the Genealogist General and Genealogy Committee which a member of the committee was kind enough to send to me. In that memo, PG Sympson states "It is imperative that reducing application approval time continues to be given a very high priority by the Genealogist General and the Genealogy Committee...I would greatly appreciate your serious consideration of my ideas for the betterment of the application process."
