There was no quorum for April meeting. Officer's Report:

Jim Lohmeyer/Chuck Adams gave Registrar's report. The following completed applications have been sent to the State of Florida: Chuck Adams and Christopher Williams. We expect to induct Chuck Adams to our Chapter during our September meeting. Patrick Woolbert will be sending in his application after his daughter becomes a member of the D.A.R. Mark Snyder will be applying to a Chapter in Cincinnati, then transferring to the Ft. Lauderdale Chapter.

Secretary, Jim Lohmeyer, made a motion to approve and accept the minutes in the last newsletter. Motion was approved. Joe Motes (Treasurer/Historian/Editor/Sgt-At-Arms) made a motion to accept and approve last month's report. Motion was approved. This month's treasury report: \$2,049.84 in the treasury. Our Chapter gave a \$350 donation to C.A.R. We purchased a "Firefighter Award" of which 75% will be reimbursed. Recipient will be determined at a later date. We will be purchasing a "Teacher of the Year" Award. We are requesting that members submit names for either one of these awards.

New Business: The table top flag stand used for meetings has been misplaced. If it cannot be located, there will be a need to purchase a new one.

We are still seeking suggestions for a professional website to be set up and hosted. Any suggestions from the membership will be highly appreciated.

Motes will be contacting the State Chapter to check for reimbursement if we continue to award to these schools and organizations. The cost of the medals is \$3.
